(b) and (c) During the visits Peking of President Tito of Yugoslavia and Mr. Vance, U.S. Secretary of State, the Chinese leaders are reported to have conveyed a general desire for having better relations with India. No concrete proposals, however, have heen made directly to India by the Chinese Government. As stated the Foreign Minister in the Press Conference of 15th October, India is desirous of furthering the process of normalisation of relations with China on the basis of the Five Principles including reciprocity and mutual benefit.

Unorganised Labour

According to available information, the number of agricultural workers in India is 47.48 million. The State-wise breakof this figure is given in the attached statement.

(b) The Constitution of India fully guarantees freedom of association to all citizens subject only to some reasonable restrains. India has also ratified recently the ILO Convention No. 141 concerning organisation of rural workers which requires the ratifying countries, inter-alia to facilitate the establishment and growth, o na voluntary basis, of strong and independent

organisations of rural workers. While Government would continue to do whatever they possibly can to promote the growth of rural workers organisations, significant results can be achieved in a reasonably short time only when voluntary organisations and trade unions take more active interest in this field.
