### Dwindling Exports under P.L. 480 Funds

869. SHRI INDRADEEP SINHA: SHRI YOGENDRA SHARMA: SHRI SANAT KUMAR RAHA:

- (a) whether it is a fact that the exports under the Indo-US agreement signed in 1974 in regard to the repayment of PL 480 funds have virtually stopped with India having exported goods worth only Rs 13 lakhs so far; and
- (b) if so, what are the details in this regard and what is Government of India's reaction thereto?

THE MINISTER OF STATE IN THE MINISTRY  $_{
m OF}$ COMMERCE CIVIL SUPPLIES AND COOPERA-TION (SHRI ARIF BAIG): (a) and (b) Yes, Sir. However exports relate ...only to Part II of the Agreement on PL 480 and other funds between the Govt, of India and the Govt, of USA signed in 1974 and are to be made out of non-PL 480 funds and not PL 480 funds. As per para 10(C) of this Agreement, exports of goods and services totalling up to \$ 100 million · over a period of 5 years are to be

made to US Govt. agencies with 75 per cent payment in dollors and 25 per cent from non PL 480 funds. Upto June, 30, 1977 purchases by US Govt. have only amounted to Rs. 13,24,330. Slow progress in these purchases is a matter of concern to the Govt. of India because more purchases would result in additionality of our exports to USA and would result in a draw-down on US held non-PL 480 funds in India. Steps are being taken to increase the exports under this agreement.

#### US Aid

In these circumstances it would not be an appropriate arrangement to appoint sitting Members of Parliament on the Boards of Directors of public enterprises.
