(a) whether it is a fact that the prices of gold have reached an all time high:

(b) if so, what are the reasons therefor;

(c) what was the average price of gold in the Indian markets during each of the last three years;

(d) whether Government have been contemplating some measures to bring down the prices of gold in the market; and

(e) if so, what decision Government have taken in the matter?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) Yes, Sir. The price of standard gold (per 10 grams) in the Bombay market touched an all time high of Rs. 706 on November 28, 1977.

(i) short supply of gold in the internal market in relation to demand

(ii) increased demand due to marriage season;

(iii) recent increase in the exports of gold ornaments:

Extension of Commercial bank facilities to community blocks in the Northern Region

(a) whether Government have decided to extend commercial bank facilities to all the Community Blocks in the Northern Region; and

(b) if so, what are the details in this regard?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATIL): (a) and (b) In pursuance of the overall objective of providing banking facilities in the hither to unbanked areas, $bank_s$ have been advised to ensure that latest by June 1978, each Community Development Block in the country is provided with at least one commercial bank branch. According to available information, there were 29 Community Development Blocks in the Northern Region as at the end of September 1977 which did not have a commercial bank branch. Of these 6 were in Himachal Pradesh, 12 in Jammu and Kashmir and 11 in Rajasthan.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERA-TION (SHRI ARIF BAIG); (a) The amount of likely expenditure and income of the Agri-Expo is expected to be of the order of Rs. 80 lakhs as per revised estimates.

(b) The small and marginal farmers will be benefited with the latest information available in the 'AGRI-EXPO-77' on the modern techniques in the field of agriculture and allied fields, namely, the new high yielding varieties of seeds for various crops of wheat, maize, paddy, pulses etc, and use of different types of fertilizers,
