THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) The Government has recently received Part I of the final report of the Indirect Taxation Enquiry Committee. Part II of the final Report is, however, yet to be received.

(b) As the Report relates to taxation proposals, among other things, the contents thereof are being treated as confidential for the present. Part I of the Report is presently under study. Since sales tax and Octroi duty both are State subjects under the Constitution, the State Governments will have to be consulted. It is too early to take any decision in the matter.
