existing number of Hindi typewriters in the Ministry of Finance is 86.

It is not possible to indicate precisely the requirements of Hindi typewriters during the next three years. The requisite number will be procured as and when needed.

#### Steps to Reover Loan From Pakistan

### \*442. SHRIMATI AMBIKA SONI: SHRI VITHAL GADGIL:

Will the Minister of FINANCE AND REVENUE AND BANKING be pleased to state:

- (a) what is the total amount which Pakistan owes to India under the financial agreements entered into with that country at the time of partition and what is the total amount of interest which accrued to India in respect of this amount up-to-date; and
- (b) what steps Government have taken during the last six months to recover the amount?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) Pakistan partition debt to India is of the order of Rs. 300 crores; the precise amount has not so far been agreed upon despite efforts made on various occasions. Under the partition arrangements concluded in December 1947, this debt was repayable by Pakistan in Indian rupees in 50 annual equated instalments of principal and interest (at 2.7/ 8 per cent annum) commencing from the 15th August, 1952. In the absence of any payment by Pakistan towards repayment of principal or interest, the accumulated interest, even at the normal rate 2.7/8 per cent), now exceeds the amount of debt due from Pakistan.

(b) No fresh efforts have been made during the last six months towards settlement of this issue.
