(b) According to the Ministers' Residences Rules, 1962 framed under the provisions of the Salaries and Allowances of Ministers Act 1952, a Union Minister is entitled to the provision of rent-free furniture and electrical appliances at his official residence up to the value of Rs. 38,500/-. No upper limit has been laid down in respect of expenditure on maintenance of the bungalows occupied by the Ministers.

(c) No, Sir.

(d) At present there is no proposal under consideration of Government to bring down the limit of Rs. 38,500 for furnishing the bungalows occupied by Ministers. The question of curtailing the upper limit of expenditure on maintenance of bungalows does not arise in view of reply to part (b) of (he Question.
