THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUN-DER): (a) and (b) Government have not recently received any request from the Chief Minister of Goa, Daman and Diu for establishing a University in that Union territory. However, in January, 1974, the Central Government had suggested to the Government of Goa, Daman & Diu that it may set up an Advisory Planning Board for formulating the lines on which the University should be developed, keeping in view the special requirements of the territory. In July, 1975, the Government of Goa, Daman & Diu sent a draft Bill for approval. It was suggested to that Government to redraft the same in the light of the recommendations made by Gajendragadkar Committee on Governance of Universities and the matter is pending with that Government.

Appointment of Physical Education Teachers in Delhi Schools

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION, SO-CIAL WELFARE AND CULTURE (SHRIMATI RENUKA DEVI BARA-KATAKI): (a) to (c) A statement is attached.

Statement

(a) According to information ceived from the Delhi Administration. no ratio has been fixed for appointment of Physical Education Teachers to the number of students in secondary schools. However, as per existing norms laid down by the Administration, one Physical Education Teacher is provided for a work load 36 periods per week. In terms teacher-student ratio this works approximately to one Physical cation Teacher for 450 students against one Physical Education Teacher for 250-400 studen's recommended by the then Central Board of Physical Education and Recreation and suggested in 1967 for adoption by the various State Governments/U.T. Admns.

According to information furnished by the University Grants Commission, the University of Delhi has accepted the Commission's recommendation that there should normally be one Director of Physical Education in a college and, participation of stuactual dents in sports activities so justifies, an additional Director of Physical Education may be provided. A parttime Director of Physical Education may be appointed for evening classes in a college.

(b) and (c) The Delhi Adminis. tration are following the norms which have been laid down by themselves. The Administration will be advised to review the position in the light of the norms recommended in 1967 by the then Central Advisory Board of Physical Education & Recreation.
