

(c) The model by laws of Primary Agricultural Credit Societies prepared by the Reserve Bank and circulated to the State Governments for adoption include the principle of universal membership for all eligible persons residing in the area, including the Scheduled Castes and Scheduled Tribes, earmarking for them a portion of credit and reservation of adequate number of their representatives in the Managing Committees of societies. Some of the State Governments have already initiated action by undertaking the necessary amendments to the Cooperative societies acts for implementing the suggestions regarding universal membership and adequate number of their representatives in the Managing Committees of the societies.

For the tribal areas separate sub-plans have been adopted. The base level cooperative credit structure is also being reorganised by creating large-sized multipurpose cooperative societies (LAMPS) at the 'Hat' level or at Block level, with the object of providing integrated credit, services and supplies in the tribal areas. The Reserve Bank has given loans to the State Governments amounting to Rs. 324.13 lakhs during the year 1976-77 to enable them to contribute to the share capital of as many as 748 LAMPS.

(a) the names and addresses of the educational, social and religious institutions, to which land has been allotted by Government at the Upper Ridge Road, New Delhi and the area of the land allotted to each institution:

(b) the criteria followed for the allotment of land to these institutions; and

(c) the names of institutions whose applications for allotment of land are pending with Government at present and by when these applications are likely to be disposed of?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT): (a) No educational, social and religious institution has been allotted land on the Upper Ridge Road, New Delhi, but one side of the law

allotted to Patel Education Society on the junction of the Pusa Road and Upper Ridge road falls on the Upper Ridge road.

(b) The allotment to the Patel Education Society was made as a part of the Pusa Road Educational Complex.

(c) No application from any educational, social and religious institutions for allotment of land at Upper Ridge Road, New Delhi is pending with the Government. However, Mahant Baba Halak Dass Siddha Hanuman Temple Trust who are in unauthorised occupation of land on Upper Ridge Road area, have asked for regularisation of their occupation. This will be considered on receipt of the report of the Committee set up by Government, to examine the cases of unauthorised occupation of Government land by religious organisations.

Loan to Navketan Society by HUDCO

• 480. SHRI RISHI KUMAR MISH-RA: Will the Minister of WORKS AND HOUSING AND SUPPLY AND REHABILITATION be pleased to state:

(a) whether it is a fact that the Housing and Urban Development Corporation has advanced a loan to the Navketan Cooperative Group Housing Society for the construction of flats in South Delhi;

(b) if so, what is the amount of the loan advanced and the number of flats proposed to be built;

(c) what was the cost per sq. ft. taken into consideration by HUDCO at the time of sanctioning the loan to the Society;

(d) what is the cost per sq. ft. which the Navketan Society is charging from its members; and

(e) whether the said Society has taken the approval of HUDCO before realising enhanced cost from the members?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT): (a) Yes, Sir.

(b) The total loan amount sanctioned by HUDCO is Rs. 106 lakhs and the number of flats to be built under that loan is 200. (60 type 'A' and 140 type 'B' of 139.4 sqm. and 102.3 sqm. area respectively).

(c) The cost taken into consideration at the time of sanctioning the loan to the Society was Rs. 631.28 sqm and Rs. 645.16 sqm. for type 'A' and 'B' respectively. This cost per sqm. does not include the cost of land administrative/supervision charges and interest on investment during the construction period.

(d) The cost works out to Rs. 714.23 per sqm. and Rs. 747.33 per sqm. for type 'A' and 'B' respectively to be charged by the Society from its members.

(e) All inclusive cost of the flats sanctioned by HUDCO to the Society works out to Rs. 99,563/- for type 'A' flats and Rs. 76,452/- for category 'B' flats. This cost is to be charged by the Society from its members. It is not known whether the Society is realising higher cost from its members than these amounts.
