in the annexure. These are not all unemployed; many are seeking better-paid or more satisfying jobs.

(b) Employment opportunities for engineers are expected to increase with the step up in investment in Irrigation, Power and Industries, especially the small scale, agrobased and service industries. A scheme for margin-money to new small-scale industries has been initiated, which is expected to stimulate self-employment of engineers and technicians.
