Memorandum

Copy of the Memorandum laid on the Table of Lok Sabha on 1-4-1977 of action on the first Report of the Commission of Inquiry set up on 3rd February, 1976, under the Commissions of Inquiry Act, 1952, to inquire into the allegations against former Chief Minister and Ministers of Tamil Nadu

The Sarkaria Commission of Inquiry submitted its first Report on 19-1-1977, which relates to 7 allegations, in respect of which inquiry has been completed. Only one allegation is not proved; the remaining are proved wholly or partly.

One of the allegations covered by the Commission's first Report relating to Aerial Spraying contracts is the subject matter of a regular case which was registered by the Central Bureau of Investigation for investigation prior to the setting up of the Commission. This allegation has been remitted to the Central Bureau of Investigation for proceeding further with the case registered by it, in the light of the Commission's findings.

As for the remaining allegations covered by the Report, the matter has been remitted to the Government of Tamil Nadu for taking necessary follow-up action on the findings of the Commission.
