THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK): (a) and (b) Government have decided not to encourage any additional new mini steel plants in the country. A total number of 206 electric arc furnace units had been licensed/registered in the past for production of plain carbon steel ingots/billets. 43 of these licences have so far been revoked Recount on οf noivimplementation of the projects. 120 licensed units had been installed by September, 1977 and remaining 38 units are in various stages of installation.
