**Setting up of a Sponge Iron Production Plant with assistance from West Germany**

1016. SHRI SANTOSH KUMAR SAHU: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether there is any proposal under Government's consideration to set up a sponge iron production plant in the country with assistance from West Germany; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) and (b). A demonstration sponge iron plant with an annual capacity of 30,000 tonnes is being set up in Kothagudem (Andhra Pradesh) with the assistance of the UNDP. The plant will be based on the SL/RN Technology of Lurgi (West Germany) with whom a contract for the supply of equipment has also been entered into. Government of India and Government of Andhra Pradesh will both participate in this project.

**Bomb Explosion in an Indian Restaurant**

(a) whether it is a fact that in a recent explosion in the Raj Restaurant

in Bristol in U. K. a number of Indians were killed;

(b) whether Government have obtained any report in this regard; and

(c) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI S. KUNDU): (a) to (c) About two months ago there was a fire, and not a bomb explosion, at Raj Restaurant in Bristol in U. K. which was not owned by an Indian. As a result of fire, 5 persons are reported to have died. No deaths or injuries to any Indian national as a result of this incident have been reported.

**US assistance or expansion of the Bokaro Steel Plant**
