THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) There are 750 Railway schools imparting education to 1,37,338 students.

(b) and (c) Railway schools are affiliated to the Boards of Education of the States in which they are located and follow the pattern of education as laid down by the State Governments. Generally speaking, the medium of Instruction followed in these schools is the regional language of the area in which the school is situated, except a few with English or Hindi as medium of instruction. "While facilities exist for teaching the mother tongue to students belonging to the area in which the school is situated, it is not possible to provide facilities for teaching of the mother tongue to each and every student in these schools.

- (c) whether Government have instituted any inquiry into the matter;
- (d) if so, what are the findings thereof; and
- (e) what action Government have taken against the defaulting officials?
