A sum of Rs. 170 alleged to have been taken from the party by the railway staff has been refunded.

Programme to fill the vacancies reserved for the Scheduled Castes and Scheduled Tribes in Class III and Class IV posts in the Railways

The programme will last for a period of 4 months. During this period all efforts will be made to make good the shortfall to the maximum extent possible. For this purpose the recruiting agencies and the Railway Administrations have been directed to conduct special recruitments and special selections limited to Scheduled Castes and Scheduled Tribes, wherever required.
