

**Amount Deposited under G.D.S.**

1044. SHRISANAT KUMAR RAH At Will the Minister of FINANCE be pleased to state the amount of total deposits under the Compulsory Deposit Scheme and the amount of deposited money refunded after the scrapping of the Additional Emoluments (Compulsory Deposit) Act, 1974?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI ZULFIQARULLAH): According to the report received from the Reserve Bank of India, the gross amount of deposits made by employees under the Additional Emoluments (Compulsory Deposit) Act, 1974 as on 25th November, 1977 was Rs. 1878-04 crores. Of this amount Rs. 387-02 crores had been repaid to the employees upto 6th May, 1977, the date from which compulsory deductions on account of additional dearness allowance were discontinued. A further amount of Rs. 221 • 95 crores was subsequently repaid to the employees upto 25th November, 1977-

**Export of crockery**

1045. SHRI F. M. KHAN-. Will the Minister of COMMERCE AND CIVIL SUPPLIES AND COOPERATION be pleased to state :

(a) whether it is a fact that Indian crockery is quite popular in some foreign countries;

(b) if so, what are the names of the countries to which Indian crockery is being exported; and

(c) what is the amount of foreign exchange likely to be earned through such exports during die current financial year?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERATION (SHRI ARIF BEG): (a) Yes, Sir.

(b) Iraq, Dubai, France, Kuwait, Nepal, Malawi and USA.

(c) During April to November of this financial year, crockery worth Rs. 50 lakhs has been exported. In addition there are orders worth Rs. 103 lakhs with the exporters.

**Gherao of Hoarders to check High Prices**

1046. SHRI F. M. KHAN : Will 'the Minister of COMMERCE AND CIVIL SUPPLIES AND COOPERATION be pleased to state :

(a) whether Government's attention has been drawn to a news item which appeared in the 'Indian Express' of the 24th September, 1977 in which he is reported to have asked the people, while addressing a seminar on 'high prices', to gherao the hoarders and

(b) if so, whether the role of the ponce and other wings of the public administration is not considered effective to deal with the problem ?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE, CIVIL SUPPLIES AND COOPERATION (SHRI KRISHNA KUMAR GOYAL) : (a) It has been incorrectly reported that the Minister for Commerce, Civil Supplies and Cooperation had asked people to gherao the hoarders. While addressing the seminar, he had stated that the involvement of the public at large is essential in maintaining the price line and in bringing about a discipline amongst the trading community. Whatever be the efforts undertaken by the Government, they would always be inadequate if they are not supplemented by the support of the general public and the social institutions. As an example, he had mentioned that in respect of commodities for which prices have been fixed or where Government orders require display of stock position and rates, the consumers' resistance either in terms of peaceful protest or social

boycott of any trader not complying with Government regulations or indulging in anti-social activities would go a long way in preventing malpractices.

(b) The State Governments have been advised to take action against hoarders, blackmarketeers and other anti-social elements in terms of the powers available with them under the Essential Commodities Act and the Orders framed thereunder. The State Governments, who are the executing agency, take appropriate action as is necessary.
