## Completion of the Kanyakumari Triuvandrum Tirunelveli Railways Line

- 17. SHRI M. KADERSHAH; Will the Minister of RAILWAYS be plea sed to state:

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN); (a) The section from Trivandrum to Nagar, coil is proposed to be completed by 1978, and from Nagarcoil to Tirunelveli by 1980, subject to adequate funds being made available.

- (b) There has been delay in completion of the project in relation to the original target date on account of the limited availability of resources.
- (c) The cost of the project has gone upto Rs. 22.70 crores against the sanctioned cost of Rs. 14.73 crores, on ac count of increase in prices, and some changes in the alignment.
