(a) A theft took place in a 3-tire Coach No. 5207 of Train No. 157 Up.

* Kashi Vishwanath Express between Bareilly and Moradabad on the night of 8th October, 1977 in which two suitcases stated to contain property

worth Rs. 13,000 were reported stolen. One accused named Krishna, son of Sagree, resident of Tiruneveli (Tamil Nadu) was apprehended by a passenger Dr. (Mrs.) T. Jayashree with the help of other co-passengers in the coach.

- (b) Government Railway Police of the State Governments who are responsible to maintain law and order are taking all possible steps within their means to prevent incidence of theft/robberies etc. on trains on the Railways.
- (c) No recommendation for the grant of reward to Dr. (Mrs.) T. Jayashree, who apprehended the criminal has been made. However, a letter of thanks has been sent by Northern Railway Administration to the lady passenger who had apprehended the culprit.
- (d) Coach Attendants are not provided on 2nd Class Sleeper Coaches. Shri R. B. Lal was the Conductor TTE manning the 3-tier coach in question. Necessary action against him will be considered on the basis of the Police report.
