SHRI HARSH DEO MALAVIYA: Sir, in view of the historical, cultural and archaeological importance of the Cooch Behar Palace, of which honourable Minister has got good knowledge, and in view of the fact that he has written a historical novel about the wife of job Charnak -- "Job Charnak Ki Bibi"-which is in Bengali and which has been translated into Hindi and which is very popular, I would like to know whether the honourable Minister would like to write a noval about the Cooch Behar Palace and also about the generals concerned.

DR. PRATAP CHANDRA CHUNDER: Sir, I thank the honourable Member for giving publicity to my novel. But, Sir, I do not propose to write anything else now.

SHRI KALYAN ROY: Sir, after this question and this reply, there will be another edition of the book.

- (g) whether Government are considering a review of their policy of allotment of land to cooperative group housing societies and if so, what are the details thereof?

PRATAP CHANDRA CHUN-According to the infor-DER): (a) mation furnished by the University of Delhi and the Bhagat Singh College authorities, some teachers went strike for a few hour in the afternoon of the 28th September 1977 in protest against the non-selection of a temporary teacher of the College against a permanent vacancy by the Selection Committee on the basis of alleged political intereference. The Selection Committee was constituted in accordance with the procedure laid down in the Ordinances of the University and the selections were unanimous. It has been denied that there was any political intereference in the selections.
