### Rise in wholesale price index

Will the Minister of COMMERCE AND CIVIL SUPPLIES AND COOPERATION be pleased to state;

(a) whether the wholesale price index of essential commodities has shown an abnormal increase during the last few months;

(b) if so, what is the month-wise break-up of the price-index so far during the year 1977 as compared to that for the year 1975 and 1976; and

(c) what factors are responsible for this rise in the wholesale price index?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI KRISHNA KUMAR GOEL): (a) to (c). A statement is laid on the Table of the House.

### Statement

(a) The wholesale price index has not shown any abnormal increase during the last few months. On point to point comparison, the rate of inflation has come down from 12.5 per cent in March, 1977 to 4.2 per cent in October 1977. Between April-October, 1977, the wholesale price index has gone up by 1.3 per cent as compared to 9.3 per cent in the corresponding period last year. The wholesale price index has been showing a declining trend during the past six weeks ending October 29, 1977. During this period the wholesale price index has gone down by 2.5 per cent.

(b) The statement is given at Annex.

(c) There are several factors responsible for rise in the wholesale pice index. Among them the most impotant has been the increase of 18 per cent in money supply in 1976-77 as against an estimated increase of about 2 per cent, in the national income. While this

year the rate of increase in money supply is being kept at lower levels, the lagged impact of the increase in money supply in the earlier year continues to be felt even now. There have been significant shortfalls in the production of some essential commodities in 1976-77, particularly in respect of pulses, edible oilseeds and raw cotton. Shortage of power has also affected production of a few Commodities in general.
