(b) what steps Government propose to take to curtail expenditure on such security arrangements as a measure of economy?

THE MINISTER OF HOME AFFAIRS (SHRI CHARAN SINGH): (a)\ Information is being collected and will be placed on the Table of the House on receipt.

(b) In order to curtail the expenditure on the security arrangements for Union Ministers, especially when tour, on instructions were issued to the State Governments etc., to simplify such arrangements and cut down costs. However, in view of the recent threats to the security of the Ministers, security measures have again been tightened.

Arrest of Shri Kekoo Maneckji, a partner of the Pillman" Aircraft Company

- 1127. SHRI SANAT KUMAR RAHA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that Shri Kekoo Maneckji a partner of the Pillman Aircraft Company of Maharashtra, which is the sole agent and consultant for the Boeing company of U.S.A., has been arrested recently by the C.B.I.; and
- (b) if so, what are the charges against him; and
- (c) what are the names of the other persons who are involved in this case?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. D. PATIL); (a) Yes, Sir.

(b) and (c) According to the First Information Report, a case has been registered by the C.B.I., for investigation, against Shri Kekoo Maneckji and others, for offences punishable

under section 56 of the Foreign Exchange Regulations Act, 1973 and Sections 162, 163 and 120-B of the Indian Penal Code. It will not be in the interest of the investigation of the case, which is still in progress, to disclose, at this stage, any further details.

Search at the residences of Shri Sultan Singh, M.P.

- (a) whether it is a fact that the houses of Shri Sultan Singh, a Mem ber of the Rajya Sabha situated at Rohtak New Delhi, and village Nijampur Majra were searched October 1977, without registering any criminal case against Mm;
- (b) whether it is also a fact that no incriminating material wag recovered during the course of these searches and the police took in its possession, fixed deposit receipts of amounts totalling to about Rupees ten thousand, in the names of Shri Sultan Singh's grand sons and grand daughter alongwith the registration papers of a tractor registered in the name of his son;
- (c) whether it is also a fact that his New Delhi residence was searched without any valid search warrant; and
- (d) if the answers to parts (a) to (c) above be in the affirmative, what action Government have taken or propose to take to avoid recurrence of such incidents involving Members of Parliament?
