India Limited have been permitted to associate with the West Bengal Electronics Industrial Development Corporation Limited which is a State Government undertaking in the ratio of 40:60 per cent investment in a ioint sector venture for the manufacture of Walkie-TaJkie sets. The application of M/s. Shaw Wallace and Company Limited, Calcuta has been approved for the manufacture of certain technical grade pesticides like Dimethoaie at a factory to be set up at Haldia. All these proposals were supported by the State Government. The details of all industrial licences including the name of the party; item of manufacture, capacity, location of the project etc., are published in 'Weekly Bulletin of Industrial Licences, Import Licences and Export Licences', Indian Trade Journal' and 'Monthly List of Letters of Intent and Industrial Licences'. Copies of these publications are available in the Parliament Library.

## Development of backward areas in the country

\*648. SHRI GUNANAND THAKUR: Will the PRIME MINISTER be pleased to

- (a) whether the Planning Commis sion has undertaken any survey of the . backward areas in the country; and
- (b) if so, what steps Government are taking to develop the backward areas of the country especially the North Eastern Region?

THE PRIME MINISTER (SHRI MORARJI R. DESAI): (a) In the course of formulation of the Plan for 1978-83 the Planning Commission is reviewing the development of areas which are relatively backward, as indicated by relevant criteria.

(b) A number of steps have been taken by Government to supplement the efforts of the state Governments for the accelerated development of backward areas in the country. These include the special programmes like the drought prone areas programme, hill and tribal areas programme, small farmers' and marginal farmers' programme, the incentive schemes for industrial development, etc. For the

North-Eastern region in particular a North Eastern Council set up by an Act of the Parliament of 1971, is being supported by Central assistance of Rs. 90 crores for the regional schemes included in the Council's Fifth Five Year Plan, in addition to the Plans of the constituent States/ Territories. The Central Government meets the gap between their resources and the Plans.
