(c) In the Navy and in the Air Force some civilian school teachers are employed as members of a cadre. In the Army, civilian teachers are held against combatant posts but if and when they become surplus, attempts are made to absorb them in the clerical cadre subject to eligibility of the candidates and availability of vacancies. In the Navy some of the civilian teachers enjoy a higher pay scale applicable to trained graduate teachers of the Kendriya Vidyalas.

It is open for investment by Large Industrial Houses and has been specifically included as such in the Industrial Policy announced on the 2nd February, 1973. These applications will be processed according to the prescribed procedures and on the merits of each case.
