As would be seen from the statement the overdraft arrangement is a continuous arrangement and the amounts repaid by the Corporation are adjusted in their account and interest is charged on outstanding balance. The Company did not draw on the facility during the months of January, February, 1977 and June to August, 1977. Repayment also had been effected in the months of December. 1976, January, 1977, February, 1977, May, 1977, October, 1977 and November, 1977. The balance outstanding according to the company's books as on end of November, 1977 is Rs. 9,75,511.78.

#### Import of raw jute

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (KUMARI ABHA MAITI): (a) and (b) Jute Corporation of India have been authorised to import raw jute from available sources on the basis of firm indents placed by the consuming mills.

(c) According to present indication, yield of jute during 1977-78 season is estimated to be about 68 lakh bales.

(d) Maximum prices for raw jute have been fixed primarily to check speculative rise in prices and to dis cipline the market.
