Recommendation of the Administrative Reforms Commission regarding heads of technical departments

- (a) whether Government have cepted the recommendation of the Commission Administrative Reforms to the effect that all technical depart ments should be manned and headed by technical personnel only;
- (b) to what extent the Central Government have implemented the recommendation; and
- (c) whether Government are comprogramme templating a time-bound for implementing the recommenda tion?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. D. PATIL); (a) to (c) A statement is laid on the Table of the House.

Statement

- The Adminisfrauve' Reforms (a) Commmssion did not make any specific recommendation to the effect that all technical departments should be manned and headed by technical personnel only. However, recommendation Mo. 2(1) and 6(1) of A.R.C. Report on Public Administration read as follows:-
 - "2(1) All posts in a functional area whether in the field or at headquarters or in the Secretariat should be staffed by members of the corresponding functional services or by functional officers not encadred in a service."
 - "6(1) Senior Management posts in functional areas should be filled by members of the respective functional services.'
- (b) Government decision on the above recommendations No. 2(i) is as under:

"The posts requiring specialised qualifications." training and experience (which have been termed 'functional' by the ARC) are already being filled by the officers possessing such attributes. Invariably such officers are found corresponding service. The basic in the principle behind this recommendation is, thus, already in operation. It will, however, be a retrograde step to extend the principle to top posts which are largely managerial in nature. The posts should be open to all. The ARC recommendation except in its application to top posts is therefore accepted and may be treated as implemented." Government decision on recommendation No. 6(i) is as under:-

"The senior management posts in organisations outside the Secretariat are already being filled by the officers of the respective services. Therefore, in actual practice, the essence of the A.R.C's recommendation is already being followed. But there does not seem to be any need

to make a formal rule in this regard as suggested by the A.R.C. On the other hand for manning senior management posts in any service the emphasis should be more on organisational ability, leadership qualities and managerial capabilities rather than on the specialised knowledge of a particular discipline, the A.R.C's recommendation, was¹, therefore not accepted."

(c) In view of (b), does not arise.

In the Army, civilian teachers are held against combatant posts but if and when they become surplus, attempts are made to absorb them in the clerical cadre subject to eligibility of the candidates and availability of vacancies. In the Navy some of the civilian teachers enjoy a higher pay scale applicable to trained graduate teachers of the Kendriya Vidyalas.
