

by Judicial Magistrate, Bhiwani in case FIR No. 106 dated 1st September, 1977, u/s. 5(2) of the Prevention of Corruption Act, 1947 and 161/165/201/ 120B/109 IPC, P.S. Sadar Bhiwani registered against Shri Bansi Lai, Ex-Chief Minister, Haryana.

(b) As a result of searches mentioned at (a) above, fixed deposit receipts valued Rs. 11,000 in the names of Saman and Inderjeet, grand-children of Shri Sultan Singh alongwith certain other documents were seized. No tractor registration documents belonging to the son of Shri Sultan Singh were seized at that time, investigation is in progress to verify whether the FDRs are Benami.

(c) Search of the portion of House No. 16, Mahadev Road, New Delhi, under occupation of Shri R. C. Mehtani was conducted in accordance with the search warrant issued by Judicial Magistrate, Bhiwani. The portion of the house under occupation of Shri Sultan Singh was not searched.

(d) The question does not arise because the searches were conducted on the authority of search warrants issued by a competent Court.
