THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH): (a) A quantity of about 24,614 tonnes of wheat affected in 'CAP' (cover and Plinth) storage by the recent rains and floods in Punjab, Haryana and Rajasthan stored by the Food Corporation of India. Out of this quantity, a quantity of 1224 tonnes has been segregated till October, 1977, as damaged and unfit for human consumption. Haryana Government has reported damage to the extent of 199 tonnes costing Rs. 2.5 lakhs. Punjab and Rajasthan Governments have reported that there was no damage to stocks held by them.

(b) The cost of the stocks damaged is Rs. 19 lakhs. As a considerable portion of the stocks unfit for human consumption will be disposed of cattle and poultry feed, the losses to that extent will be reduced.

(b) During my stay in USSR from 13th to 16th September, 1977, I met H.E. Mr. A. Kosygin, Prime Minister of U.S.S.R. and discussed with him matters pertaining to cooperation between India and U.S.S.R. with particular reference to fields of education and culture. I also had fruitful discussions with H.E. Mr. P. Demichev, Minister of Culture and H.E. Prof. V. P. Yelutin, Minister of Higher and Secondary Specialised Education, U.S.S.R. on subjects of mutual interest. With Mr. Demichev I discussed the development of the arts and crafts, specially theatre. With H.E. Prof. Yelutin, the important question of joint text books on scientific and technological subjects was discussed.

I also inaugurated the Festival of Indian Art and Culture in Moscow on 15th September, 1977.

THE MINISTER OF STATE IN THE MINISTRY OF WORKS AND HOUSING AND SUPPLY AND RE-(SHRI HABILITATION KINKAR): (a) and (b) Regularisation of unauthorised occupation in respect of allotable properties was discontinued since March, 1963.

- (c) Yes. Sir.
- (d) There are 42 such properties. Out of these, it has been decided to make offers of sale by negotiation under Rule 87 of the Displaced Persons (Compensation and Rehabilitation) Rules 1955 to the occupants in 18 cases. Proposals for the remaining properties are under consideration.

#### Arid Lands

- (a) whether it is a fact that the Arid Zones in the country particularly in Rajasthan are on the increase:

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI PRATAP SINGH): (a) So far aridity or arid areas increase/expansion is concerned there is no scientific evidence to suport this belief.

- (b) The following are some of the major steps taken to reclaim areas affected by aridity:-
  - (i) The Central Arid Zone Research Institute, Jodhpur, is undertaking intensive research to work out the scientific technology for increasing agricultural production in the arid areas of the country.

(ii) During the Fifth Five Year Plan Government of India is implementing a Drought Prone Areas Programme (DPAP), for economic betterment of these areas. The Fifth Plan allocation for this Programme is Rs. 181.50 crores.

A Desert Development Programme has also been started from the current year. This year's outlay for this Programme is Rs. 6.10 crores.

- (iii) Rajasthan Canal is under way which will irrigate 1.14 million Ha. by gravity irrigation and 51,000 Ha. by lift canal in the districts of Ganganagar, Bikaner and Jaisalmer.
- (iv) Report of the National Commission on Agriculture "Desert Development" is under consideration of the Central and State Governments for implementation in the next Five Year Plan.
