

well as the Gujarat Agricultural University and the officers of Agriculture Department, Gujarat have visited the affected areas and collected samples for detailed examination. The real cause of the disease is under investigation. A research project has been prepared by the Gujarat Agriculture University to take up intensive work on this problem which requires detailed studies. In the meantime the Gujarat State Department of Agriculture has suggested certain prophylactic measures to be adopted by the banana growers to keep the disease under check. Briefly these are :

(1) Planting of healthy, disease free suckers available in Banana Multiplication Centres in the State.

(2) Treatment of suckers with aureofungin before planting.

(3) Planting in well drained soils and drenching the soils with suitable chemicals before the onset of monsoon.

(4) Spraying the trees at appropriate intervals commencing from the time when the crop is three months old.]

Accumulation of Huge Stocks of Sugar

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether it is a fact that huge stocks of sugar have accumulated in various godowns in the country as a result of the suspension of sugar exports; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH): (a) and (b) A quantity of 1.13 lakh tonnes of unshipped stocks of levy free sugar released for export are lying in godowns in the various ports and with the sugar mills. Out of these a quantity of about 47,000 tonnes is lying at the port godowns, as detailed below, and the balance of 66,000 tonnes is lying with the sugar mills who stock the sugar till release.
