THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) Yes, Sir.

(b) During the last three years new mineral occurrences of kyanite in Bhandara district; manganese in Yeotmal district and barytes in Chandrapur district in Maharashtra have been located.

(c) Systematic geological mapping and appraisal of mineral occurrences is in progress in Yeotmal district.

Will the Minister of PARLIAMENTARY AFFAIRS AND LABOUR be pleased to state;

(a) whether it is a fact that the employment exchanges in Delhi/New Delhi start sending interview calls to the candidates for various posts after 3 years of their registration and stop sending interview calls after 5 calls are sent to a candidate without ascertaining as to whether the candidate had got a job or not;

(b) if so, what are the reasons therefor; and

(c) whether Government propose to issue instructions to the employment exchanges to issue regular calls to the candidates until they are finally employed?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) and (b) Nomination of candidates by Employment Exchanges against demands of the employers is governed by established principles of referral policy, consistent with seniority and suitability of candidates. No period is prescribed after their registration when the registrants in Employment Exchanges in Delhi/New Delhi are sponsored. The waiting period depends upon the size of the Live Register in each category. In the case of surplus categories, however, in order to give chances of submission to a larger number of registrants, a 'Rotation System' is followed, as a part of the referral policy, by which after 5 submissions, further sponsoring is withheld for some time with a view
