### Construction of a bridge on Brahmapura at Silghat

### 201. SHRI NABIN CHANDRA BU-RAGOHAIN: SHRI C. P MAJHI:

Will the Minister of HOME AF-FAIRS be pleased to refer to the answer to Unstarred Question 555 given in the Rajya Sabha on the 4th August, 1977 and to state:

- (a) whether any steps have been taken for the construction of the second bridge over Brahmaputra at Silghat by the North Eastern Council at its meeting held on the 22nd August, 1977; and
- (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRJ DHANIK LAL MANDAL): (a) and (b) The North Eastern Council considered the detailed project of the second bridge over Brahmaputra at Silghat in its tenth meeting on 22nd and 23rd August, 1977. The Council is including this project in the next Plan with the proposal that the construction of the Silghat bridge be either taken as Central Scheme or special allocation be made for its construction as a regional project.

## Pension to Minor sons of deceased Freedom Fighters

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI DHANIK LAL MANDAL):
(a) and (b) Under the Freedom Fighters' Pension Scheme, sons of freedom fighters are not eligible for grant of pension unless it is established that they could not come up in life owing to the imprisonment/martyrdom of their fathers. The question of extending the scope of the scheme to cover minor sons has been considered but it was decided not to widen the scope of the Scheme any further
