- LAL K. ADVANI): (a) to (c). A Committee of experts set up in September, 1976 to examine the feasibility of colour felevision being introduced on experimental basis, interalia, recommended:
- (i) Experimental colour television could be introduced at Delhi, with facilities for one hour live transmission per day supplemented by film footage and provision of an OB van to enlarge the scope of activities.
- (ii) A foreign system most suitable for the indigenisation angle may be adopted; and development work initiated to increase indigenous content of equipment.
- (iii) Components required for development of colour television receivers might be imported.
- (iv) A group of engineering and programme personnel should be trained abroad in colour television to form mucleus for training of others,

According to the estimates of the Committee, the comparative figures of expenditure involved in colour and black and white television are:

Colour Black and white

Capital cost of 2-studio television station. 8.62 crores 5.83 crores

Per hour cost of programme production 25,000 \$8,000

The comparative cost of a colour television receiver is three to four times that of a black and white receiving set.

In view of the heavy outlay involved and limited financial resources available, it is not possible to consider the introduction of colour T.V. in the country in the near future.
