THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJPAYEE) : (a) and (b) The process of normalisation of relations with Pakistan is continuing. After the imposition of Martial law in Pakistan, the two Governments signed an agreement

in New Delhi on consular facilities for their airlines personnel on August 1977, and an agreement 31. on Telecommunications in Islamabad on October 1, 1977. A delegation of the Indian Oil Corporation signed an agreement with representatives of Pakistan Refineries and National Refineries for the export of furnace oil and naphtha from Pakistan to India, on October 28, 1977, at Karachi. Trade and travel between the two countries have been going on as usual.
