(b) The limit of free calls on Minister's telephones is 250 calls per quarter as for other subscribers.

Deposits of Vanadiferrcus ore in Orissa

323. SHRI C. P. MAJHI : Will the Minister of STEEL AND MINES be pleased to state:

(a) whether it is a fact that there are huge deposits of vanadiferrcus ore in Mayurbhunj District in Orissa; and

(b) whether there is any proposal under Government's consideration to exploit these deposits in that area?

THE MINISTER OF STATE IIS THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA) : (a) Vanadiferrous magnetite deposits occur in several parts of Mayurbhanj district of Orissa. So far about 2 million tonnes of ore containing one per cent Vanadium pentaoxide have been proved in Kumardhubi and Betjharan areas and another 3 million tonnes have been inferred from other localities in the district.

(b) A proposal to set up a project for production of Ferro-vanadium in Orissa was under consideration of the Govern-nent. It has since been decided that this project should be implemented by Govern-ment of Orissa.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI NARHARI PRASAD SUKHDEO SAI) : (a) Yes, Sir.

(b) The news item alleges about— (i) Poor out-turn of Trunk operator, (ii) Heavy absenteeism of operate rs. (in) Higher ineffectiveness of the trunk call:

(iv) Allegation of passing free calls, (v) Provision of transport to operators: (vi) Poor performance of STD calls. (c) No, Sir. The absenteeism, the outturn and the percentage effectiveness of trunk/STD are of the same order as obtaining in other Metropolitan cities.
