THE MINISTER OF PARLIAMENTARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) and (b) Presumably, reference is to the tool down strike by the workers of this unit during September, 1977. The matter falls essentially in the State sphere. According to available information, there was a tool down strike by the workers of the HMT watch factory at Srinagar on September 26, 1977 for expeditious acceptance of their demands. The strike was called off on September 27,1977 following an assurance by the management regarding expeditious implementation of the outstanding demands and resolution of grievances of the workers.

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) A meeting was held with the Chief Executives of the Steel Authority of India Limited and its subsidiaries at Rourkela on 23rd September, 1977, when it was decided that possibilities of installation of captive cement plants of one million tonnes capacity each at Bhilai, Rourkela and Bokaro should be examined with a view to utilising the surplus blast furnace slag and also the lower grade limestone ari-sings from the captive mines.

- (b) Action is being taken by the steel plants to draw up viable scheme.

### Letter thrown into the Indian Tourist Office in New Bond Street, London

THE MINISTER OF **EXTERNAL** AFFAIRS (SHRI ATAL **BIHARI** VAJPAYEE): (a) Yes, Sir.

- (b) At about 0200 hours on 9th October 1977, the police patrol found the front sheet glass window at the Indian tourist office smashed up. The Director of the Tourist Office was informed and she rushed to the office immediately. There, a brick was found to which was; tied a typed message of threat addressed to the Prime Minister.
- (c) The High Commission of India,. London, immediately contacted the local agencies for ensuring adequate protection to the various Government of India offices and their personnel. This has been done.
