THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA) : (a) and (b) SAIL International Limited is considering setting up of an office in U.S.A. The proposal is in a very preliminary stage of consideration.

**Control over Iron ore Mining**

(a) whether it is a fact that about 70 per cent of the iron ore mining and its export marketing is controlled by private mine owners; ]

(c) whether there is any proposal under Government's consideration to bring the entire iron ore mining industry in the public sector ; if so, what are the details thereof?

**Sponge Iron Plants**

315. SHRI PRANAB K. MUKHERJEE: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether Government of India have received any proposal from the Government of Yugoslavia for financing sponge iron plants in the country; and

(b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA) : (a) and (b) At a meeting of the Sub Group on Indo-Yugoslav Industrial Co-operation held in New Delhi on 18th/19th May, 1977 the prospects for setting up a sponge iron plant in India with Yugoslav collaboration was noted and it was agreed that the feasibility report prepared by the India side would be further discussed with a team of experts from Yugoslavia. These discussions were accordingly held on 18th October, 1977 and have brought out that taking account the alternative demands for gas from Bombay High for higher priority uses e.g. fertiliser etc. and its relatively high price, production of sponge iron may not be economically feasible. Both sides have therefore, agreed to explore the possibility of collaborating in the set-

ting up of sponge iron plants in their countries where cheaper gas may be available.

#### Steel Plant at Paradeep

316. SHRI PRANAB MUKHERJEE: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether Government propose to set up a three million ton export-based steel plant at Paradeep in Orissa; and

(b) if so, what are the details in this regard ?

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK):" (a) and (b) Government is considering 'the feasibility of setting up three port-based, export-oriented plants at Visakhapatnam, Mangalore and Paradeep. Capacity of such plants, their product-mix and the time-table for setting up such plants would depend on growth of internal and external demand of Steel.
