THE MINISTER OF EXTERNAL AFFAIRS (SHRI ATAL BIHARI VAJPAYEE)
: (a) Yes Sir, a delegation from Bangladesh visited India in September to resume negotiations on sharing of the Ganga waters.

(b) At the end of the talks, an agreement on sharing of the Ganga waters at Farakka and augmenting its flows was reached between the two Governments and initialed. The agreement was signed at the Ministerial level in Dacca on November, 5, 1977. A copy of the Agreement was laid on the Table of the House on 14th November, 1977.

Sponge Iron Plants

- 315. SHRI PRANAB K. MUKHERJEE: Will the Minister of STEEL AND MINES be pleased to state:
- (a) whether Government of India have received any proposal from the Govern ment of Yugoslavia for financing sponge iron plants in the country; and
 - (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): (a) and (b) At a meeting of the Sub Group on Indo-Yugoslav Industrial Cooperation held in New Delhi on 18th/19th May, 1977 the prospects for setting up a sponge iron plant in India with Yugoslav collaboration was noted and it was agreed that the feasibility report prepared by the India side would be further discussed with a team of experts from Yugoslavia. These discussions were accordingly held on 18th October, 1977 and have brought out that taking account the alternative demands for gas from Bombay High for higher priority uses e.g. fertiliser etc. and its relatively high price, production of sponge iron may not be economically feasible. Both sides have therefore, agreed to explore the possibility of collaborating in the set-
