PROF. MADHU DANDAVATE: Sir, there is a table which gives the information.

MR. CHAIRMAN: Will you read the whole table?

PROF. MADHU DANDAVATE: Sir, it is a small one. As far as the payment is concerned, the table is small, Now, as far as the claims are concerned, the number of claims received on behalf of those killed is 74; from injured—10, those grievously from those having received injuries-26. Thus, the total number of claims is 110. The number claims disposed of by the Claims Commissioner is 43 in the case of those killed, in the case of those received grievous injuries, 8 out of 10, in the case of those having received simple injuries, 22 out of 26. On the whole, out of 110, 73 claims have been disposed of. The compensation paid to the nearest kin of the killed is Rs. 6,13,874; in the case of those grievously injured, it is Rs. and in the case of those having received simple injuries, it is Rs. 51,930. The total compensation paid Rs. 7,14,004.

SHRI NABIN CHANDRA BURA-GOHAIN: Shri Shaukat Ali had lost two of his minor sons and a minor daughter. Is it a fact that his claim had been rejected on the ground that he was not dependent on his minor son or minor daughter, though he was their legal heir? If that be the legal position, may I ask the hon. Minister whether he will provide some pecuniary compensation to such category of claimants on the grounds of compassion, equity and hardship?

PROF. MADHU DANDAVATE: There are certain set norms and rules by which the Claims Commissioner conducts his work. May be, the particular case which he has mentioned did not conform to the set norms and rules. But I will inquire into the case and, even if it could not be settled on the basis of compensation by the Claims Commissioner—if the case is genuine—I will try to see if anything

could be done through the Minister's Relief Fund.

Toilet facilities in Second Class compartments.

Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government are aware that the toilet facilities in second class compartments in most of the trains are far from satisfactory which results in great inconvenience to passengers;
- (a) whether Government are aware that water taps provided in such compartments are of inferior quality and do not work properly; and
- (c) if the answer to parts (a) and (b) above be in the affirmative, what steps are being taken to bring about improvements in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SHEO NARAIN): (a) to (c) A statement is laid on the Table of the Sabha.

Statement

- (a) Toilet facilities in II class coaches in service are generally satisfactory, except for occasional complaints of inconvenience caused to passengers due to poor cleanlines, or non-availability of water in the toilets.
- (b) Standard type of water taps, viz. spring loaded push cocks, are provided in all toilets and their working has been generally satisfactory.
- (c) Special attention is paid to ensure proper cleanliness of toilets and

availability of water in them throughout the run of the train. Push cocks with improved type of springs are being provided to replace those which are found hard and difficult to operate.

पर मैं इन्तजाम करवा रहा हूं।

श्री हर्षदेव मालवीय: मान्यवर, थोड़ी सी इन्होंने ग्रपनी पोजीशन वदली कि कुछ जगहों पर ठीक नहीं है। क्या ग्रापको मालूम है कि नलके से जो पानी निकालना पड़ता है उसके लिए हाथी के जोर की जरूरत पड़ती है, हाथी की ताकत लगानी पड़ती है। ग्रापने कितनी ताकत लगाई थी?

श्री शिव नारायण: श्रीमन, ट्रेन में कोई हाथी नहीं चलता है, इन्सान चलते हैं। लेकिन इनको ग्रगर हाथी की ताकत लगानी पड़ती है तो मैं इनकी तारीफ करूगा कि हाथी का बल इनके पास है। लेकिन हाथी ट्रेन में कोई चलता नहीं। हम उसका इन्तजाम कर देंगे।

MR. CHAIRMAN: Shri Ranga please be brief.

SHRI N. G. RANGA: I am always brief. I brought to the notice of both the Ministers the fact that the second

class passengers are having a raw deal as bad as it was for the earlier third-class passengers. Is it not a fact that not only the lavatories are dirty but the accommodation is more crowded and sweepings, dust and everything is there and nothing is being done in order to help the passengers, especially those travelling in the non-express trains?

SHRI SHEO NARAIN: Sir, I may assure the hon. Professor that I am trying to develop everything. We are giving new coaches on the 1st October. We are developing a brand new train.
