South Asian Rail System

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE):
(a) and (b) A statement is laid on the Table of the Sabha.

Statement

The idea of Trans Asian Railway Project had been conceived by Economic and Social Commission for Asia and the Pacific (formerly Eco_ nomic Commission for Asia and Far East) as the linking of Railways of the region with those of European and African systems would greatly contribute to and accelerate the region's economic, social and cultural development. In South Asia the missing rail links are in Indonesia, bet_ Ween Thailand, Burma and Bangladesh and between Pakistan and Iran, and these would involve very heavy capital investment. Studies for construction of the various missing links have been taken up in the past which were financed by the U. N. D. P. The drastic curtailment in U. N. D. P's budget has, however, adversely affected further progress of this Project.

India has no missing rail links in the Trans Asian Railway Project in the mainstream between Pakistan and Bangla Desh. India has from time to time supported this Project and offered fo give technical assistance to the countries concerned in carrying out the surveys for new rail lines, rehabilitation of railway net-work and modernisation of techniques.

Laying of Railway Lines in backward areas
