- (a) what is the number of air hostesses of foreign nationalities, nationality-wise, serving in the Air-India and the Indian Airlines, respectively; and
- (b) what are the reasons for employing foreign nationals as air hostesses?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTTAM KAUSHIK): (a) A statement is laid on the Table of the Sabha.

(b) Foreign nationals are employed as air hostesses because their knowledge of foreign languages stands them in good stead in looking after foreign nationals who do not know English or Indian languages. Besides, all international airlines employ hostesses of foreign nationalities. Similarly, Indians are employed as air hostesses by foreign airlines also.

Bonus by L.I.C. on Policies

*739. SHRI GOVINDRAO RAM-CHANDRA MHAISEKAR: Will the Minister of FINANCE be pleased to state:

- (a) whether Government propose to revise the rates of bonus given to L.I.C. policyholders: and
- (b) whether Government also propose to revise the rates of levy premia on policies in view of the fact that life expectancy has risen from an average of 27 to 55 years in India, if not, what are the reasons therefor?

THE MINISTER OF FINANCE AND REVENUE AND BANKING (SHRI H. M. PATEL): (a) No Sir. Bonuses to holders of life insurance policies are declared at periodical actuarial valuations. On the basis of its latest biennial valuation as at 31-3-1977, the Life Insurance Corporation has only recently declared bonus of Rs. 25 per thousand sum assured per annum on whole life policies and Rs. 20 per thousand sum assured per annum on endowment policies, as against the earlier bonus declarations of Rs. 22.00 and Rs. 17.60 respectively.

(b) There is no proposal at present under consideration of the LIC to reduce premium rates. Premium rates under various without profit plans of assurances were reduced from time to time during the years 1970 to 1976. In the case of with-profit policies it is customary not to make frequent changes in the premium rates but to give effect to the experience in bonus declarations.

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOT-TAM KAUSHIK): The condensers form an integral part of the air-conditioning plant and the cost of the condensers has not been separately reflected in the contract placed on the firm entrusted with air-conditioning of the Air Route Surveillance Radar building at Nangloi. The condensers fitted by the firm in the air-conditioning plant were found to be unsatisfactory and the firm replaced those condensers without any additional charge.
