- (c) if the reply to part (b) above be in the negative, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI DHANIK LAL MANDAL): (a) to (c) According to Statements furnished to the Police, there was an altercation between a visiting group of students from Gujarat and an employee of Gandhi Smirti who was acting as a guide. On being informed, the police reached the spot and restored peace.

No further action was taken by the police as no commission of a cognizable offence was made out.

# **Modernisation of Textile Mills**

THE MINISTER OF INDUSTRY (SHRI GEORGE FERNANDES): (a) to (c) Government has issued orders to the IDBI to the effect that the NTC Mills would also be eligible for assistance under the Soft Loan Scheme for modernisation. The applications for assistance under this scheme are submitted by the NTC directly to IDBL. The NTC has so far applied to the IDBI for soft loans totalling Rs. 112.41 lakhs. The pre-sanction and post-sanction procedures of IDBI with regard to sanction and utilisation of loans applicable to the NTC Mills will be the same under the scheme as are applicable to mills in the private sector.
