bent cotton. The matter has been taken up with the Ministry of Finance and the Ministry of Industry (Textiles Division) to evolve a suitable defini-nition of raw cotton so as to prevent misuse of the policy of allowing exports of absorbent cotton of pharmacopoeia standards.

## Income-tax arrears of film artistes
