(b) if so, what is Government's reaction thereto?

THE MINISTER OF FINANCE (SHRI H. M. PATEL): (a) and (b) It is in the issue of the Hindustan Times dated 7th November, 1977 (and not in the issue of the Hindustan Times dated 12th November, 1977, as stated in part (a) of the Question) that a news item appeared wherein it had been stated that "the British Overseas Development Minister has given virtual notice to India that the current level of British aid may not be maintained unless there is continued understanding by the recipient country".

In the issue of the Hindustan Times of the 12th November, 1977, however, the Hindustan Times Correspondent has himself reported that a spokesman of the Ministry of Overseas Development of the British Government had denied that any ultimatum had been given.

Both the Governments are equally keen to ensure the fullest utilisation of aid extended by Britain to India and various proposals in this context are under the consideration of the Government.

Tourist traffic to Assam

(b) The India Tourism Development Corporation plans to construct a hotel in Gauhati on the site on which the Department of Tourism had started -constructing a tourist bungalow. The project will be taken up for implementation subject to the availability of funds.
