mined by the Ali India Institute of Medical Sciences quite a good number were found to have excessive lead in their blood and 6 children had it even in their bones; and

(c) if so, what steps Government propose to take to remedy the situation?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI JAGDAMBI PRASAD YADAV): (a) Use of lead in printing press can be a health hazard to the workers who come in contact with lead during the course of their duty. Children who chew magazines, newspapers and other non-food materials are at a risk of absorbing excessive amounts of lead which may lead to lead poisoning.

- (b) An estimation of lead was done in the blood of 100 children with pica (the habit of ingesting or mouthing non-food object) and 100 control children. Some children had blood-lead level higher than that in children who did not eat non-food objects.
- (c) 1. In the printing presses the following steps are taken usually:
  - (i) General examination of workers and treatment to them whenever they are suspected of having lead poisoning.
  - (ii) Workers who are handling lead during the course of their duty are advised to take calcium tablets and drinking of milk.
  - (iii) Such workers are advised to take plenty of fluids while working and at home.
  - (iv) Alternate jobs other than handling lead are given to the workers suspected of having lead poisoning.
- 2. Health Education of parents is necessary to see that children do not ingest non-food objects in order to prevent them from lead poisoning.

# Study conducted by the Calcutta Medical Research Institute on Blood Donated by Professional Donors

- (a) whether it is a fact that a recent study conducted by the Calcutta Medical Research Institute on the quality of blood of professional donors has revealed that in 9 out of 10 cases blood has been found to foe deficient in haemoglobin and thereby cannot benefit the patients to whom such blood is transfused;
- (b) whether, it is a fact that the donors of blood included persons suffering from syphilis; and
- (c) if so, what steps Government propose to take in this regard at the national level?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) and (b) The C.B.I. investigated the complaints and submitted their report. They recommended departmental action against the Director,

Central Tuber Crops Research Institute, Trivandrum. An enquiry into the allegations is now being made by the Commissioner for Departmental Enquiries, Central Vigilance Commission, New Delhi.

### Loss of Foreign Exchange Earnings and Employment opportunities due to Prohibition

624. SHRI F. M. KHAN: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:

- (a) whether Government have made any assessment regarding the loss in foreign exchange earnings and the number of persons likely to be rendered unemployed as a result of enforcement of complete prohibition in the country; and

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) The speed and manner in which the policy of complete prohibition will be enforced by the State Governments is not yet known. Hence, it is premature to estimate the loss of foreign exchange earnings and the exact number of persons who will become unemployed as a result of implementation of total prohibition.
