## Closing of Bar in the Administrative Staff College of India

- 604. SHRIMATI VIDYAWATI CHATURVEDI: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:
- (a) whether it is a fact that a bar for serving liquor is functioning in the Administrative Staff College of India, Hyderabad at present;
- (b) whether it is a fact that Government have given a licence to the College to import liquor;
- (c) whether Government propose to close down the bar; and
- (d) if not, what are the reasons therefor?

THE MINISTER OF EDUCATION, SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) Yes, Sir.

- (b) Yes, Sir. It has been obtaining licence for Rs. 1500 a year for import of liquor.
- (c) and (d) Government have told the college authorities to close down the bar.

## Delay in Payment of Salaries to DMC School Teachers

- (a) whether Government are aware that teachers working in the Delhi Municipal Corporation Schools in different Zones are not given their salary in time;

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION. SOCIAL WELFARE AND CULTURE (SHRIMATI RENUKA DEVI BARA-KATAKI): (a) to (c) According to information received from the Delhi Municipal Corporation, salaries of the teachers working in schools under the control of the Corporation are disbursed before 10th day of every month. The Headmaster of the concerned school. have to visit the Zonal Offices of the Corporation once a month to collect the salaries of the teachers. The Delhi Municipal Corporation has stated that they have found this to be the most viable arrangements for the purpose of disbursement of salaries of concerned teachers.
