## SEFERENCE TO ALLEGED SERIOUS SITUATION IN MATTAN ANANT-NAG DISTRICT JAMMU AND KASHMIR—Contd.

SHRI SYED NIZAM-UD-DIN: Sir, on 29th July, there was a police firing in Mattan which resulted in the death of 3 persons and scores of people were injured. The situation had started becoming serious about fortnight before 29th July 1978. But the Government of Jammu and Kashmir despite full information about the happenings showed indifference. was because of this callous attitude and wilful negligence of the Goverment that the situation kept on deteriorating everyday, and finally resulted in the unfortunate happenings of 29th July. Sir, in the initial stages, Government having remained completely indifferent and allowing the situation to deteriorate, resorted to shooting without any justification and reason. As far my information is concerned, the police firing was totally unwarranted. police shot at women and children of the town. The procession was at all violent till the firing place.

Sir, the indifference of the Sheikh Government at the beginning was there because the trouble was engineered by their on workers. It was only after there was a threat of cancellation of the procession of Chari Mubarak that the Government became panicky and resorted to much more force than necessary.

A few days before the land dispute, there was a fish-catching net found in the spring. This was to arouse communal passion in the area and when it did not work, then the interested people started the land dispute.

Sir, the situation continues to be highly tense and explosive till this day. People are not allowed to move from one place to another place.

Sir, this is not an isolated incident. There are other disputes of recent origin of the same nature. The lines and the slogans on which the National Conference fought the elections have directly contributed to such a situation. The matter has become more serious in view of the Amar Nath Yatra. Sir, in view of the situation created there, the Central Government is duty-bound to take direct interest and keep a strict vigilance over the situation. The valley of Jammu and Kashmir has throughout remained noncommunal and the situation now prevailing is somewhat serious.

Therefore, Sir, I bring this to the notice of the Central Government because some interested sections in the Kashmir valley are creating a situation over which the Central Government must keep a strict watch. It is the duty of the Central Government to keep a strict vigilance and also directly talk to the Government of Jammu and Kashmir and take whatever steps possible to restore normalcy in the area because Amar Nath Yatra is going to take place only after a few days.
