Minister, what I have said is I have accused you of Mr. Education Minister, there is a serious charge made by the Professors of the University. Again you have started the same thing and if the lungs are taken out for this charge, I do not mind because I do not want the McCarthy functioning in the Education Ministry and the Prime Minister's House being involved in this

MR. CHAIRMAN: Please resume your seat.

SHRI BHUPESH GUPTA: Will you kindly tell Mr. Pratap Chandra? If at your age you are your department of McCarthy, at my age can I not put a question even? Sir, have you got it? Will you tell him?

MR. CHAIRMAN: Yes.

SHRI RISHI KUMAR MISHRA (Rajasthan): On a point of order, Sir. Why are you not listening to a point of order? The hon. Education Minister has made a very obnoxious remark saying that the Member should learn how to speak relevant. I think you should pull up the Minister for making such an unparliamentary remark. It is unparliamentary. He should not say it. It is absolutely objectionable.

SHRI BHUPESH GUPTA: How long has he been in Parliament? Only one year. He is teaching morals to me. (Interruptions)

SHRI MANUBHAI PATEL (Gujarat): Was it relevant, Mr. Bhupesh Gupta? You spoke about Jawaharlal Nehru University. This is about Delhi University. Highly irrelevant.

SHRI RISHI KUMAR MISHRA: Sir, you allowed hon. Shri Bhupesh Gupta to make a reference. If he was making a statement which is not relevant, it is within the purview of any Member to get up and object that what he is speaking is not relevant and you can direct the Member to modify his statement and to be the point. It is not at all proper and we take strong

objection that a Minister should get up and speak in an arrogant manner to a senior Member that what he is saying is not relevant.

MR. CHAIRMAN: The guestion is:

"That in pursuance of item (xix) of clause (1) of statute 2 of the Statutes of the University of Delhi, this House do proceed to elect, in such manner as the Chairman may direct one member from among the members of the House to be a member of the Court of the University of Delhi."

The motion was adopted

MOTION FOR ELECTION TO THE CENTRAL SILK BOARD

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (KUMARI ABHA MAITI): Sir, I beg to move:

RE. ALLEGED THREAT TO THE LIFE OF A MEMBER

SHRI YOGENDRA MAKWANA: I do agree with you that I should file a complaint with the police. That I am going to do. But last night at 11.30, when I was coming after attending the Executive meeting, Mr. Satyanarayana, Member, Lok Sabha, was with me. We parted company at the bus stop. When I was going towards my block, two persons accompanied me. One was in trousers and kurta and the second was wearing a bushirt and pant.

SHRI PILOO MODY: Kalp Nath

SHRI YOGENDRA MAKWANA: Both of them, from appearance I can say and from their talk-they talked politely with me in the beginning. They said: "What about the motion to be moved tomorrow?"
