the entire Boarder States of the country. The allotment of a new Border Area Project depends on various considerations such as backwardness of the area, availability of accommodation, the consent of the State Government concerned to bear 1/3rd of the total expenditure on the Border Area Projects etc. Keeping these factors in view, only six projects could be started in the Border Areas of West Bengal starting from 1976-77 based on the recommendations of the West Rengal State Social Welfare Advisory Board.

(c) During the current year 1978-79, three more Border Area Projects have already been sanctioned in the West Bengal.
