**Shortfall in Production in Steel Plants**

1353. SHRI SITARAM KESRI: Will the Minister of STEEL AND MINES be pleased to refer to the reply to Unstarred Question 529 given in the Rajya Sabha on the 21st July, 1978 and state the extent of shortfall in production in each steel plant as a result of the short supply of coal during the last six months?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI KARIA MUNDA): Due to the short supply of coking coal during the last 6 months, it became necessary to reduce the pushing rate of coke ovens at some of the Steel Plants to avoid further depletion of the coking coal
