- (a) whether it is a fact that he has cancelled his scheduled visit to Sri Lanka and Geneva in July,, 1978; and
- (b) if so, what are the reasons therefor? THE MINISTER OF **EXTERNAL** AFFAIRS (SHRI ATAL BIHARI VAJPAYEE): (a) Yes,, Sir.
- (b) The Foreign Minister could not undertake these visits due to unavoidable reasons. His visit to Sri Lanka has been postponed to a mutually convenient date later in the year. As regards Geneva, the Minister of State in the Ministry of External Affairs led the Indian Delegation to the meeting of the Economic and Social Council of the United Nations

- (c) whether it is also a fact that the Steel Authority of India and SAIL International have not even cared to acknowledge the request made by the co-operatives; and
- (d) if so, what action Government propose to take in the matter?
