preparing a feasibility study, for setting up an
export-oriented alumina plant of three lakhs
tonnes per annum capacity in Gujarat State.

(a) whether India and Turkey **have** recently entered into an agreement for economic and technical cooperation between the two countries; and

(b) if so, what are the terms of **the** agreement?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI S. KUNDU): (a) and (b) **Yes** Sir.

During the recent visit of the Turkish Minister of Foreign Affairs, an agreement has been entered into on 13th July, 1978, on economic and technical cooperation between the Government of India and the Government of Turkey. The agreement envisages cooperation in the economic, industrial and technical fields. Possible fields of cooperation are likely to cover, *inter alia*, exchange of experts and technicians and training facilities, besides joint promotion of studies and schemes likely to contribute to the social and economic development of the two countries. Another area of cooperation concerns the setting up of joint ventures and other forms of collaboration in the industrial and agricultural fields, communications and consultancy.
