## Project Report for the Construction of Fishing Harbour at Nuagarh in Puri District of Orissa

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state :

(a) whether it is a fact that at the instance of the Central Govern ment a project report has been pre-investment prepared the by survey of Fishing Harbour for the construction., ^ fishing harbour at Naugarh ne<sup>^</sup>." starang in the Puri district of Orissa providing facilities for landing and for berthing me chanised fishing boats ;

(b) if so, what' is the estimated cost of the project and what will be the share o^the Orissa Government there in ; and

(c) what are the ns for the delay in sanctioning the project ?

THE MINISTER OF STATE IN THE MINISTRY OF AGRI CULTURE AND IRRIGATION (SHRI BHANU PRATAP SINGH) : (a) Yes, Sir.

(b) The estimated cost of the project is Rs. 66 lakhs of which Rs. 20 lakhs is to he the share of the State Govt.

(c) As the State Govt, planned to introduce a much larger fleet than envisaged in the project report, it became necessary to review the technical designs of the harbour and economics of the Pro Eventually in June, 1978 iect. the State Govt, agreed to operate а smaller fleet envisaged in as the project report. The project is now under consideration for invest ment decision.

SHRI BHAIRAB CHANDRA MAHANTI : Sir, in which year did the Government of India ask the Government of Orissa to prepare the scheme and what is the likely tonnage of fish that will be netted if this scheme is given effect to ?

SHRI BHANU PRATAP SINGH : Sir, the quantity of fishing is not mentioned. But the original plan was to have a port in which 40 vessels could enter and get serviced. Later on, the State Government increased the number from 40 to 420. That meant that the scheme had to be revised. But in the mean— time, the State Government has returned to its original position-that of service facility for only 40 vessels.

SHRI BHAIRAB CHANDRA MAHANTI : Whatever the number of vessels was—whether 40 or 420— there must have been some estimate of fishing done. So, I want to know the quantity of fish, in terms of tonnage, to be netted if this scheme is given effect to, and what the likely foreign exchange to be earned on that account is.

SHRI BHANU PRATAP SINGH: That figure is not available, and it is also very difficult to get an estimate of what would be the catch afcer the port has been completed.

SHRI LAKSHMANA MAHAPATRO : I want to know from the hon. Member Minister whether, in addition to this fishing harbour at Naugarh near Astarang, there are proposals about Gopalpur and other small fishing harbours on the coast | of Orissa. If so, what steps are I being taken to attend to them? The second thing that I want to know is this. He has said that Rs. 20 .lakhs will be the share of Orissa. '

Was it mentiond in the original project report that this would be the amount or did the Central Government want it to be raised to Rs. 20 lakhs from something lower proposed earlier ?

SHRI BHANU PRATAP SINGH : We are considering some otner projects, for example, Gopalpur and Hansua, and these are also being considered. As regards the latter part of the question, the contributions made by the Cerntal Government and the State Governments, as I have said earlier, Rs. 45.87 lakhs or Rs. 46 lakhs were made by the Central Government and Rs. 19.95 lakhs or nearly Rs. 20 lakhs was made by the State Government on the Nuagarh fishing harbour project.
